3-8-21 1357 hrs.

A 60 yr. old female from Upper Darby was taken into custody for stealing over \$54 worth of household items from the Giant 700 block W. Sproul Rd. She was released, and charges for Retail Theft will be filed.

3-8-21 1459 hrs.

A resident of the 200 block S. Highland Av. reported his Mongoose bike stolen from the front porch.

3-9-21 0947 hrs.

Target security at the mall reported a male subject had left the store with several electric toothbrushes for which he did not pay. Responding officers found the subject in the rear of the mall property and took him into custody. The male possessed a quantity of marijuana and was also found to be the same subject who had stolen from Target on prior occasions.
