5-10-22 2009 hrs.

Officers responded to the area of Kennerly Rd. and Maddock Rd. for a domestic dispute involving a male and his parents. Officers found the male, 34 yrs. old from Drexel Hill, was intoxicated and took him into custody. He was released the next day and will be charged with Disorderly Conduct and Public Drunkenness.

5-10-22 2259 hrs.

A 32 yr. old male from Springfield was taken into custody after being found intoxicated on the 200 block Alliston Rd. and attempting to damage property. He was released the next day and will be charged with Disorderly Conduct and Public Drunkenness.

5-11-22 1458 hrs.

Officers were called to the CVS Store 700 block Baltimore Pk. for a report of a female stealing OTC medication and vitamins and who may have been involved in prior thefts from other CVS stores. Officers located Elizabeth Rechenberg 30 yrs. old from Philadelphia walking out of the store with stolen merchandise valued at over \$500. She was taken into custody and found to have active arrest warrants from Philadelphia, Chester, and Delaware counties. She was transported to Delaware County Prison and will be charged with Retail Theft.

Gregory Chavous 37 yrs. old from Philadelphia was arrested and charged with Retail Theft after employees at the Rite Aid 100 block Saxer Av. reported he had stolen over \$1100 worth of OTC medication. The male was held for arraignment and later transported to Delaware County Prison.

The scooters were recovered and valued at close to \$700. Anthony Boone 34 yrs. old from Philadelphia was charged with Retail Theft and other offenses and arraigned. He was found to have multiple active arrest warrants for prior violent crimes. He was later transported to Delaware County Prison.

Officers investigated a crash on State Rd. at Springfield Rd. in which a vehicle drove through a red signal and struck a vehicle turning left. The driver, 42 yrs. old from Springfield, was found to be intoxicated and taken into custody. He was released to medical personnel for treatment, and charges for DUI and traffic offenses are pending.

Officers were called to Williams Park 100 block Powell Rd. to investigate a male subject reportedly smoking marijuana. Upon making contact with the male, the male began to create a disturbance by yelling and screaming and refusing to cooperate and provide his name. The male was taken into custody for identification purposes and later released. He is a 23 yr. old from Springfield. Charges for twp. park violations and drug offenses are pending.
