11-18-24 0826 hrs.

A resident of the 300 block Northcroft Rd. reported a Range Rover vehicle stolen from the street sometime 11-16-24, and the key fob may have been left inside the vehicle. On 11-18 at about 1106 hrs. Philadelphia PD located the vehicle and made two arrests.

11-18-24 1848 hrs.

A 33 yr. old male from Philadelphia will be charged with Retail Theft. Security at Target at the mall reported he stole over \$200 worth of items by concealing them inside a reusable type bag and walked out of the store.

11-19-24 1304 hrs.

Security at Target at the mall reported a male had stolen numerous items from display and walked out with a hoverboard. The male fled through the mall and to a vehicle. Responding officers located the suspect vehicle on Baltimore Pk., and the male was taken into custody. Jessie Brown 37 yrs. old from Drexel Hill was charged with Retail Theft and held for arraignment.

11-19-24 1835 hrs.

Target security 800 block Baltimore Pk. reported three subjects had stolen \$700 worth of merchandise and fled the store on foot. Responding officers located the suspects on the 1000 block E. Woodland Av. A juvenile and adult female from Glenolden, and an adult male from Philadelphia were taken into custody. All will be charged with Retail Theft.

A 24 yr. old female from Darby will be charged with Retail Theft after she was observed by employees at BJ's Wholesale using an old receipt and failing to pay for items in her shopping cart. She had tried to leave with a quantity of soap product that was not paid for.

A resident of the 400 block Hawarden Rd. reported the front storm door had been struck and the glass cracked by a small projectile sometime after 11-21.

Target security at the mall reported a male had stolen a vacuum cleaner and left the area in a pickup truck. Sgt. Officers were called to Baltimore Pk. near Sproul Rd. to investigate an unconscious male driver of a vehicle. Upon arrival, the vehicle began to drive away from the scene into Swarthmore Borough. The vehicle continued to drive, failing to stop for police. The driver stopped on Thomson Av. to make a U-turn, and as officers attempted to make contact with the driver, he accelerated back towards Sproul Rd. On Sproul Rd. two police vehicles were struck by the driver causing minor damage, and the driver continued into Upper Darby Twp. until finally being stopped. Stephen Leopold 32 yrs. old from Drexel Hill was found to be under the influence of opioids and possessed a quantity of suspected heroin and drug paraphernalia. He submitted to a blood test and was held for arraignment.
