10-31-23 1601 hrs.

Officers were called to the Citadel Credit Union 900 block W. Sproul Rd. for a report of a male subject attempting to withdraw money from an account and using a fake identification card. They located the male who had completed a withdrawal slip and presented a fake PA identification card with the account holder's name. John Kallaur 49 yrs. old from Brooklyn, NY was arrested and charged with Forgery and related offenses. He was held for arraignment.

10-31-23 1732 hrs.

Officers located an unconscious male in the driver seat of a running vehicle stopped on Leamy Av. at Prospect Rd. Just prior to forcing entry, the male awoke and opened the door. He was found to be intoxicated and taken into custody. The 42 yr. old from Morton refused a blood test. Charges for DUI will be filed.

11-3-23 0424 hrs.

Officers responded to an alarm activation at a business on the 600 block Baltimore Pk. As they entered the property, they observed a male walking away from the building carrying a tool bag. The male was in possession of drug paraphernalia used to inject heroin and was taken into custody. The business did not appear to have been burglarized. Jeffrey Weaver 42 yrs. old from Philadelphia was charged with drug offenses and held for arraignment.

A 42 yr. old female from Springfield will be charged with Retail Theft after security at Target 800 block Baltimore Pk. observed her steal close to \$120 worth of beauty products. Target reported the female has been involved in multiple other thefts from the store.
