8-7-23, 1704 hrs.

Target, 1200 Baltimore Pike, reported a shoplifter in custody. Monique Rochelle Wright, 34 years old from Philadelphia, attempted to leave the store with \$309 of unpaid merchandise. She was turned over to police for processing. Wright was charged with Retail Theft.

8-7-23, 1836 hrs.

Target, 857 Baltimore Pike, reported a shoplifter in custody. Kemonnie Oliver, 25 years old from Philadelphia, concealed baby clothes and items under a blanket in her stroller and attempted to leave the store.
